


ADMINISTRATIVE ORDER NO. 18-606

Williams Sts., Greenfield District, Mandaluyong City, where majority of the Directors were present, the following resolution was unanimously approved:

WHEREAS, relative to Section 1 (c) Article V of Republic Act No. 7922, also known as Cagavan Special Economic Zone Act of 1995, CEZA is conferred to approve, accept, accredit and allow any local or foreign business, enterprise or investment in the Zone subject only to such rules and regulations as CEZA may promulgate from time to time in conformity with the provisions of this Act and the limitations provided in the Constitution

WHEREAS, pursuant to Section 37 of the Rules Implementing the Cagayan Special Economic Zone Act of 1995, which provides that CEZA may charge reasonable fees for the acceptance, processing, issuance and renewal of applications, certificates and other similar documents that may be required under these Rules;

WHEREAS, the imposition of the proposed Fees is a vital step in maintaining CEZA's competitiveness as compared with other economic Zones in the country;

WHEREAS, under Section 7 (g) of the By-Laws of the Board of Directors of the Cagayan Economic Zone Authority which states that the Board has the authority to adopt or confirm fees, dues and charges that may be imposed by CEZA;

RESOLVED, that the CEZA Board of Directors approves, as we hereby approve, the Proposed Adjustment of CEZA Fees in Relation to the Frontline Services Provided Under the Business Processing and Regulatory Division.

Proposed Adjustment of CEZA Fees

The Cagayan Economic Zone Authority (CEZA) was created through Republic Act 7922 and is mandated to oversee the operations and development of the Cagayan Freeport. CEZA, through the same Act, has the power to approve, accept, accredit and allow any local or foreign business, enterprise or investment in the Cagayan Freeport subject only to such rules and regulations as CEZA may promulgate from time to time. Moreover, Section 37 of the CEZA Implementing Rules and Regulations states that CEZA may charge reasonable fees for the acceptance, processing, issuance and renewal of applications, certificates and other similar documents. Furthermore, compared to other special economic zones and freeports, CEZA has the lowest rates for the services offered such as enterprise registration, certifications, and permits, among others.

In view of the of the foregoing, the following adjustment of fees to be collected in relation to the frontline services provided under the Business Processing and Regulatory Division is hereby recommended:
